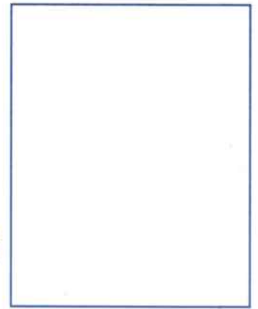

Extracts from the Institute's Constitution and Bye-Laws. (2010 edition)

(1) Membership Requirements

(a) Fellows (FSIET) Entrance Fees : S\$80.00, Annual Subscription S\$100.00

Fellows shall be persons

- (i) who are not less than 30 years of age.
- (ii) who have passed the prescribed Fellowship examination of the Institute, or in possession of an equivalent qualification * thereof; and
- (iii) who have been engaged for at least 5 years in a senior position of responsibility in engineering, or of equivalent standing, and have satisfied the Council that they are worthy of election as Fellow.

*e.g. *Advanced Diploma in Engineering awarded by Singapore Polytechnic / Ngee Ann Polytechnic; Registered Resident Engineer (BCA)*

(b) Members (MSIET) Entrance Fees : S\$60.00, Annual Subscription S\$80.00

Every candidate for election or transfer to the class of Member shall satisfy the Executive Council that he can comply with the following conditions:

- (i) that he is at least twenty-five years of age
- (ii) that he has attained a satisfactory standard of general education
- (iii) that he has passed the prescribed Corporate Membership Examination of the Institute, or in possession of an equivalent qualification ** thereof.
- (iv) that he has at least five years experience in engineering or related practice, which shall include two years practical training or site works and three years involving responsibility connected with design research, construction, production or engineering works.

**e.g. *Diploma in Engineering awarded by Singapore Polytechnic / Ngee Ann Polytechnic; Registered Technical Officer (BCA)*

(c) Associate Members (AMSIET) Entrance Fees : S\$40.00, Annual Subscription S\$60.00

Every candidate for election or transfer to the class of Associate member shall satisfy the Executive Council that he can comply with the following conditions:

- (i) that he is at least twenty-three years of age
- (ii) that he has attained a satisfactory standard of general education
- (iii) that he has passed the prescribed Associate Membership Examination of the Institute, or in possession of an equivalent qualification *** thereof.
- (iv) that he has at least three years experience in engineering practice.

***e.g. *Higher Nitec in Engineering awarded by ITEs.*

(d) Associates (Assoc. SIET) Entrance Fees : S\$30.00, Annual Subscription S\$50.00

Associates shall be persons qualified in some other science, art or profession allied to engineering, and therefore not qualified for any other class of membership of the Institute, but whose association with the Institute considered by the Executive Council as conducive to the general advancement of special techniques or engineering knowledge.

(2) Entrance Fees and Annual Subscriptions

- (a) The annual subscription shall be due on the 1st of January in each year.
- (b) Members elected after the 1st day of July in any year shall for that calendar year pay half such annual subscription.
